<u>Cleveland Foundation Endowment Fund First Quarter Report</u>

Ms. Ritchey reported that the library received the January 1 through March 31, 2020 statement for the Shaker Heights Public Library Fund at the Cleveland Foundation. The fund started the year with a balance of \$156,957.67. As of March 31, 2020 the balance is \$137,047.48. The net decrease to assets is \$19,910.19.

New Business

Mr. Meinhard recommended prioritizing key financial planning tasks at the July Finance Committee meeting.

Mr. Cicarella would like to revisit where the expenses will be reduced to keep the library on track for the same net cash reserve as originally budgeted for 2020. He would like to see those adjustments in future forecasts.
