Code of Conduct Draft Revision

As a first step in reviewing and revising how we manage customer behavior and public space, the work group consisting of the Deputy Director, Branch Manager, Security and Safety Manager, and Adult and Youth Services Managers has drafted a revised Code of Conduct. Goals for revising the Code include:

- Seeing that our spaces and staff are welcoming, inclusive, and as much as
 possible, safe, for all members of our community, including staff, while our
 Code of Conduct remains clear and enforceable.
- Reducing bias in policies and procedures and in enforcement of them.
- Provide staff with the tools they need to maintain a positive public space.

The draft of the revised Code of Conduct was discussed. Suggestions for further edits to the document were made by the Board members. Those revisions will be drafted and shared with the committee via email. If that final draft is accepted by the committee, it will be shared with the full Board for approval at the regular meeting on August 21. Once it is approved by the full Board, the work group will proceed with revising related behavior management procedures and training of staff.
